- 1. I , Rajesh Karunakaran, Practicing Company Secretary (F.C.S. No. 7441) ,appointed as Scrutinizer by :
- (I) the Board of Directors of Foseco India Limited (the Company ) for the purpose of scrutinizing evoting process in a fair and transparent manner—under the provisions of Section 108 of the Companies Act , 2013 (the 2013 Act ) read with Rule 20 of the Companies (Management and Administration ) Rules 2015 as amended and

- 2. The Management of the Company is responsible to ensure compliance with the requirements of the Companies Act 2013 and Rules relating to remote e-voting and poll on the resolutions contained in the Notice to the Annual General Meeting of the Members of the Company.
